## **GUIDELINES FOR FILLING OUT THE CONVERSION / TRANSFER FORM**

This form is common for all categories of investors. Make sure that you have read the relevant Trust Deed(s) and Offering Document(s) before filling out this form.

## Information about the Account Holder

i) In case of a Conversion / Transfer Form being filled by the guardian, on behalf of a minor(s), the name of the minor(s) as well as of the guardian should be written clearly on the form and the guardian's signature should be recorded in the specified section.

#### **Details of Certificates:**

- ii) If the Account Holder ticks in the "Yes" option, he/she needs to disclose the distinctive certificate(s) number, surrendered.
- iii) Conversions / Transfers cannot be made unless original certificate(s) are surrendered. (Only if they were issued to the investor).

#### Details of Conversion

iv) In this section, the details of the conversion from one fund to another is to be filled mentioning the Quantity (Units) or Amount in Rupees.

#### **Details of Transfer:**

v) In this section, the details of the Transferor and Transferee is to be filled mentioning the Quantity (Units) or Amount in Rupees.

### **Other Instructions:**

- vi) For the purpose of operating joint accounts please make sure the Joint Account Holder(s) sign this form as per the options selected in Account Opening Form.
- vii) In case of institutions this section shall be used for authorized signatory and rubber stamp should be affixed for each signatory of the institution.

The form should be authenticated by his/her/their banker.
